**Noteworthy Information:**

One closed misdemeanor criminal record filed on May 2, 2005 for driving while intoxicated was located in Illinois at the Cook County Circuit Court. 1. The address traces for Jonathan Mejr, accessed with the Social Security number provided on the employment application, listed addresses in the following counties:

- \* Cook County, Illinois (1996 - 2007)
- \* Lee County, Illinois (2000)

A Level IV pre-employment background investigation was conducted in Cook County, Illinois. Searches were not conducted in Lee County, Illinois as the address was reported only once.

2. The Registrar's Office at the University of Chicago in Chicago, Illinois verified that Jonathan S. Mejr was awarded a Juris Doctorate degree on May 16, 2000.
3. A source with the Illinois State Bar Association verified that Jonathan Mejr was issued attorney license number 13026543 and admitted to practice on July 2, 2001. No disciplinary actions were reported.
4. The subject's current employment with Brown & Brown LLP in Chicago, Illinois was not verified directly. However, the firm's Web site ([www.brown&brown.com](http://www.brown&brown.com)) lists the subject as an associate in the Evanston office. On his resume, Mr. Mejr stated that he was employed in 2001 as a summer associate, and has been employed since 2002 as an associate.
5. The subject's employment with Gold, Staley & Pip LLP in Chicago, Illinois could not be verified because the firm is no longer in existence. On his resume, Mr. Mejr stated that he was employed in 2000 as a summer associate.

## **Detail of Investigation – Continued**

### **A) Jonathan S. Mejr**

6. The subject's credit report, dated July 23, 2007, listed ten accounts, all of which are being paid or have been paid as agreed.
7. The Illinois driving record indicates that a license was issued to Jonathan Mejr on May 12, 1991, which expires on April 11, 2008. A violation of driving while intoxicated was reported on May 2, 2005 (see below.)
8. No felony criminal records identifiable with the subject were located in Illinois at the Cook County Circuit Court. One 2005 misdemeanor criminal record for the charge of driving while intoxicated was found at this court, as noted below. (The record is identifiable with the subject by full name and date of birth.)
