The narrative portions of the report represent only the elements for which records were found. The summary charts provide the results of all searches and their jurisdictions and/or sources. Unless otherwise noted, all records have been matched to the subject by name, address, known associates and/or a combination of these.

Notations:

One criminal misdemeanor record filed June 7, 2008 was located in Ohio at the Cuyahoga County Court of Common Pleas that listed Colin Troves as defendant. Troves was charged with one count of simple assault and one count of reckless endangerment. Troves pleaded guilty to both charges, was sentenced to probation, and fines and costs totaling \$2,635. A news article reported that Troves assaulted his aunt because she was cleaning the family house with a dog-hair-ridden mop. Police said Troves knocked his aunt's head into a wall, unplugged phones to keep her from getting help and dragged her back into the house when she tried to flee. **See Section B-2 for an excerpt of the article and Section B-4 for the case index.**

One dismissed civil lawsuit filed in 2007 was located in New York at the New York County Supreme Court that listed AutoWorld, Inc., Colin Troves, et al. as defendants in a breach of contract complaint filed by Tribeca Specialty Detailing. **See Section A-6.**

A. AutoWorld Inc. (f.k.a. Special Motors)

1. A Level III investigation was conducted under the names AutoWorld, Inc. and Special Motors in New York County, New York.
2. The New York Secretary of State records indicate that AutoWorld Inc., at the address noted above, is an active domestic company that incorporated on February 15, 1999. NY Corporation Services was identified as the registered agent at 546 West 207th Street, New York, NY 10034. The New York Corporate number is 00123456.
3. The business credit report, dated December 1, 2009, listed the subject's name as AutoWorld Inc. (The subject changed its name from Special Motors to the present trade style in 2005.) Started in 1999, the subject operates as a specialty auto sales dealership, and is reported to have branches in New York, New York; Detroit, Michigan; Cleveland, Ohio and Miami, Florida. Colin Troves is identified as chief financial officer. A copy of the report is included in the attachment.
4. Searches of media sources located numerous articles and references dated between 2000 and 2010 regarding AutoWorld Inc. and its operations as a rare and specialty auto dealer based in New York. No negative information was reported. One article noting the company's expansion in 2006 has been cited below and included in the attachment along with other articles.

A) AutoWorld Inc. (f.k.a. Special Motors)

October 8, 2006, Showroom Today: AutoWorld, Inc. CFO, Colin Troves has a lot to smile about these days as he announces the expansion of the specialty auto seller's presence in new markets. "We've been able to tap into a market that our competitors were unable to support and our expansion is the next logical step to offer our products and services on a wider scale," said Troves at a celebration for the company's grand opening of showrooms in Miami and Detroit. AutoWorld, Inc. (formerly Special Motors) is based in New York and now operates specialty dealerships up and down the east coast. When asked about the possibility of AutoWorld moving west, Troves said that the company will wait until the time is right. "After all," Troves added, "Our timing has been impeccable so far and we don't want to risk what has been a very good business for us and our investors."

1. The address traces for Colin Troves indicated that the subject also has been known as Colin Michael Troves, and listed addresses in the following counties:

- * New York County, New York (1999, 2002-2010)
- * Cuyahoga County, Ohio (1991-1997, 1999 and 2001)

A Level III investigation was conducted under the names Colin Troves and Colin Michael Troves in New York County, New York and additional searches for civil litigation, criminal records (felony index), tax liens, judgments and bankruptcy filings were conducted in Cuyahoga County, Ohio.

2. Several articles dated between 2000 and 2010 were located in searches of media sources that referenced Colin Troves and his affiliation as chief financial officer with AutoWorld, Inc. One article quoting the subject in this position has been cited in Section A-4. In addition, one article published in 2008 that reported on the subject's arrest for assault is excerpted below and included in the attachment.

July 30, 2008, Cleveland News Today: At a court hearing on June 17, a 62-year-old woman, reportedly beaten on the morning of June 6 by her 32-year-old nephew because she was cleaning with a dog-hair-ridden mop, declined to testify against her kin. Instead, Francine Troves sat outside the courtroom while a police officer testified that when he arrived at the Troves' home, he heard her say she had been beaten by her nephew.

B) Colin Troves

The nephew, who is the chief financial officer of specialty car dealers AutoWorld, Inc. based in Manhattan, was charged with aggravated assault and related offenses. Troves was released on his own recognizance, said a court officer. Police said Troves knocked his aunt's head into a wall, unplugged phones to keep her from getting help and dragged her back into the apartment when she tried to flee. She managed to call police. On July 26, Troves pleaded guilty to simple assault and reckless endangerment and was sentenced to probation, a domestic violence education program and fined.

3. As noted in Section A-6, one dismissed civil lawsuit filed in 2007 was located in New York at the New York County Supreme Court that listed AutoWorld Inc., Colin Troves, et al. as defendants in a breach of contract complaint.
4. One 2008 criminal (misdemeanor index) record, noted below, was located in Ohio at the Cuyahoga County Court of Common Pleas that listed Colin Troves as defendant.
